## RULES AND REGULATIONS

## State of California

In the light of the state of extreme emergency now existing in the City and County of San Francisco and pursuant to the authority vested in me to promulgate, issue and enforce rules, regulations and orders, I deem the following rule and regulation necessary for the protection of life and property:

## 1. CURFEW

No person shall be upon the public street, avenue, alley, park, or other public place or unimproved private realty within the areas bounded as follows:

Starting at the intersection of Hunters Point Boulevard and Evans Avenue proceeding westerly on Evans Avenue to Mendell Street, then south on Mendell Street to Galvez Avenue, then west on Galvez Avenue to Newhall Street, then south on Newhall Street to Kirkwood Avenue, then west on Kirkwood Avenue to Phelps Street, then south on Phelps Street to Oakdale Avenue, then westerly on Oakdale Avenue to the Alemany-Potrero Freeway, then westerly along the Alemany-Potrero Freeway to the Bayshore Freeway, then southerly on the Bayshore Freeway to the intersection of Phelps Street, then northeasterly on Phelps Street to Williams Avenue, then east on Williams Avenue to Third Street, then south on Third Street to Yosemite Avenue, then easterly on Yosemite Avenue to Keith Street, then northerly on Keith Street to Van Dyke Avenue, then east on Van Dyke Avenue to Jennings Street, then north on Jennings Street to Thomas Avenue, then east on Thomas Avenue to Ingalls Street, then north on Ingalls Street to Shafter Avenue, then east on Shafter Avenue to Hawes Street, then north on Hawes Street to Palou Avenue, then easterly on Palou Avenue to Crisp Road, continuing easterly along Crisp Road to the Hunters Point Naval Shipyard, and thence northerly along the shipyard property line to Innes Avenue, then west to Hunters Point Boulevard, then north to the starting point.

Starting at the intersection of Jamestown Avenue and Third Street northerly along Third Street to Fitzgerald Avenue, then east on Fitzgerald Avenue to Ingalls Street, then north on Ingalls Street to Egbert Avenue, then easterly on Egbert Avenue to Hawes Street, then north to Carrol Street, east to Fitch Street, south to Gilman, west to Giants Drive, then south following the line of Giants Drive to Jamestown Avenue, then westerly on Jamestown to the starting point.

Starting at the intersection of Willow Street and Laguna Street, south on Laguna to Haight Street, then west on Haight to Buchanan Street, then south on Buchanan to Hermann Street, then west on Hermann to Duboce Park west along the north edge of Duboce Park to Scott Street, then south on Scott to Duboce Avenue, then west on Duboce Avenue to Castro Street, then northwest to Divisadero Street and north on Divisadero to Haight Street, west on Haight to Buena Vista and south on Buena

Vista to Waller Street, west on Waller to Ashbury Street, south on Ashbury to Frederick Street, west on Frederick to Clayton Street, south on Clayton to Carl Street, west on Carl to Cole Street, south on Cole to Parnassus Avenue, west on Parnassus Avenue to Stanyan Street, north on Stanyan to Oak Street, east on Oak to Masonic Avenue, north on Masonic Avenue to Fulton Street, east on Fulton Street to Central Avenue, north on Central Avenue to Turk Street, east on Turk to St. Joseph's, north on St. Joseph's to O'Farrell Street, east ~~to Pierce Street~~, south to Ellis Street, east to Steiner Street, north to ~~Sutter Street~~, west to Pierce Street, south to Post, west to Scott, north to Sutter, west to ~~Divisadero Street~~, south on Divisadero to Geary Street, west on Geary to Presidio Avenue, north on Presidio Avenue to California Street, east on California to Webster Street, south on Webster to O'Farrell Street, east on O'Farrell to Hollis Street, south on Hollis to Ellis Street, south around the school yard and to the west end of Willow Street at Buchanan Street, and thence east to the starting point at Willow and Laguna Streets.

This curfew shall be effective at 12:00 midnight, September 27, 1966, and shall last until sunrise the following day and between the hours of 8:00 p.m. and sunrise each following day until such time as this rule is rescinded. This curfew shall not apply to policemen, peace officers, firemen, other emergency personnel or civilians engaged in police or emergency work. This rule shall not apply to authorized representatives of any news service, newspaper, or radio or television station or network.

No person within the curfew area shall be permitted to sell, furnish or give away alcoholic beverages during the curfew period.

Any violation of this rule shall be punished as provided by Section 1600 of the Military and Veterans Code.
